Helen had been long active in The American Begonia Society and has two prized Begonias named after her: Helene Jaros, ABS R#449, rhiz, Chumash x Bow-Joe, Lowe, Fl, 1972.

Her son, Charles, took the reins early on and has formerly been and is now currently (2012) President of the American Begonia Society. Charles is a noted horticultural exhibitor and international horticultural judge. Charles works for the U.S. Border Control/Customs in Florida.

The American Begonia Society presented Helene with the Eva Kenworthy Gray Award, given to an individual for contributing something of a spiritual value toward cementing goodwill and harmony among members; and/or contributing original material toward helping the rank and file members further their study of begonias. The winner of this year's award certainly cemented goodwill from the first time I met her at the 1980 convention in Long Beach, California. She asked me to sign her convention program, I was an unknown and she made me feel welcome. I'll always treasure the time we've spent at conventions as that is the only times I've been able to see her. She always has a smile on her face, a kind word to share and I hope to have her energy when I get older. She travels through the begonia world sharing herself with all. Helene Jaros is a generous and giving person and certainly deserving of this award.

She was an employee with the former Penn Beaver Hotel, Rochester, and Palace Inn, Daugherty Township. She was a graduate of the Florida Miami Dade County Community College, where she received her teaching certificate. A Lutheran by faith, she was a member of the American Begonia Society, where she was a credited judge; a life member of the Palm Beach and Miami Branch of the American Begonia Society, and a charter member of the Tampa Bay Begonia Society. She was preceded in death by her husband, Charles Jaros, in 1995; a grandson, Bruce W. Noss Jr., and two sisters, Margaret V. Hansen and Mildred M. Dishler. Surviving are two sons and a daughter-in-law, Charles J. Jaros, with whom she resided in Sanford, Fla., and Richard A. Sr. and Jean Kammer, Freedom; a daughter and son-in-law, Valerie M. and Bruce Noss, Norfolk, Va.; four grandchildren, Richard A. Kammer Jr. and his wife Misty, John L. Kammer and his wife Kimberly, and Christopher C. Kammer, all of Freedom, and Tina M. Kammer, Pittsburgh; three great-grandchildren, Jennifer N. Kammer, Nicole D. Kammer and Joshua L. Kammer, all of Freedom, and several nieces and nephews. Friends will be received Tuesday from 2 to 4 and 7 to 9 p.m. in the WILLIAM MURPHY FUNERAL HOME INC., 349 Adams St., Rochester, where a service will be conducted Wednesday at 11 a.m. The Rev. 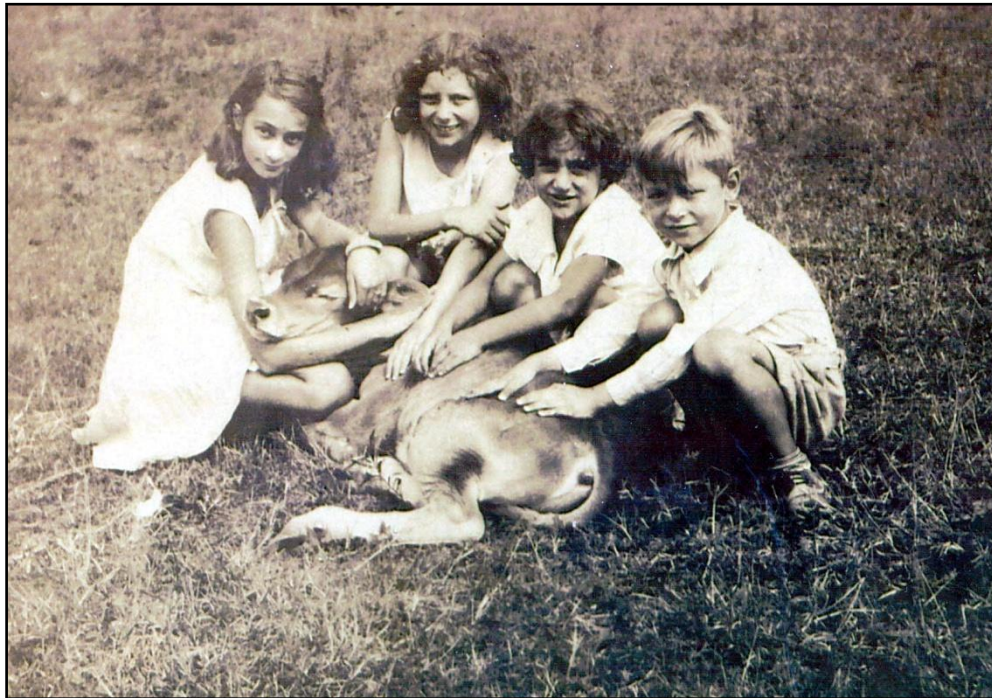

Mildred Mae Sinkovitz married Richard Carl Graham in 1945 and issued no children. Mildred then married Leroy John "Pete" Dishler in 1958 and had one daughter, Peggy Ann Dishler.

Peggy was born in 1959 and is a sweet lady with a longstanding medical problem. Peggy suffers from schizophrenia, and symptoms were apparently evident when she was in her early twenties.

I was not aware of her condition and learned of it only a few years ago. To make problems worse, Peggy lost her mom in 1999 and her father died in 2004. Peggy also has no siblings. She has been living in an assisted living facility near Pittsburgh, Pennsylvania, maintained by a trust set up by her father. We have tried to keep in touch with Peggy and send her gifts at Christmas and her birthday. God bless her.

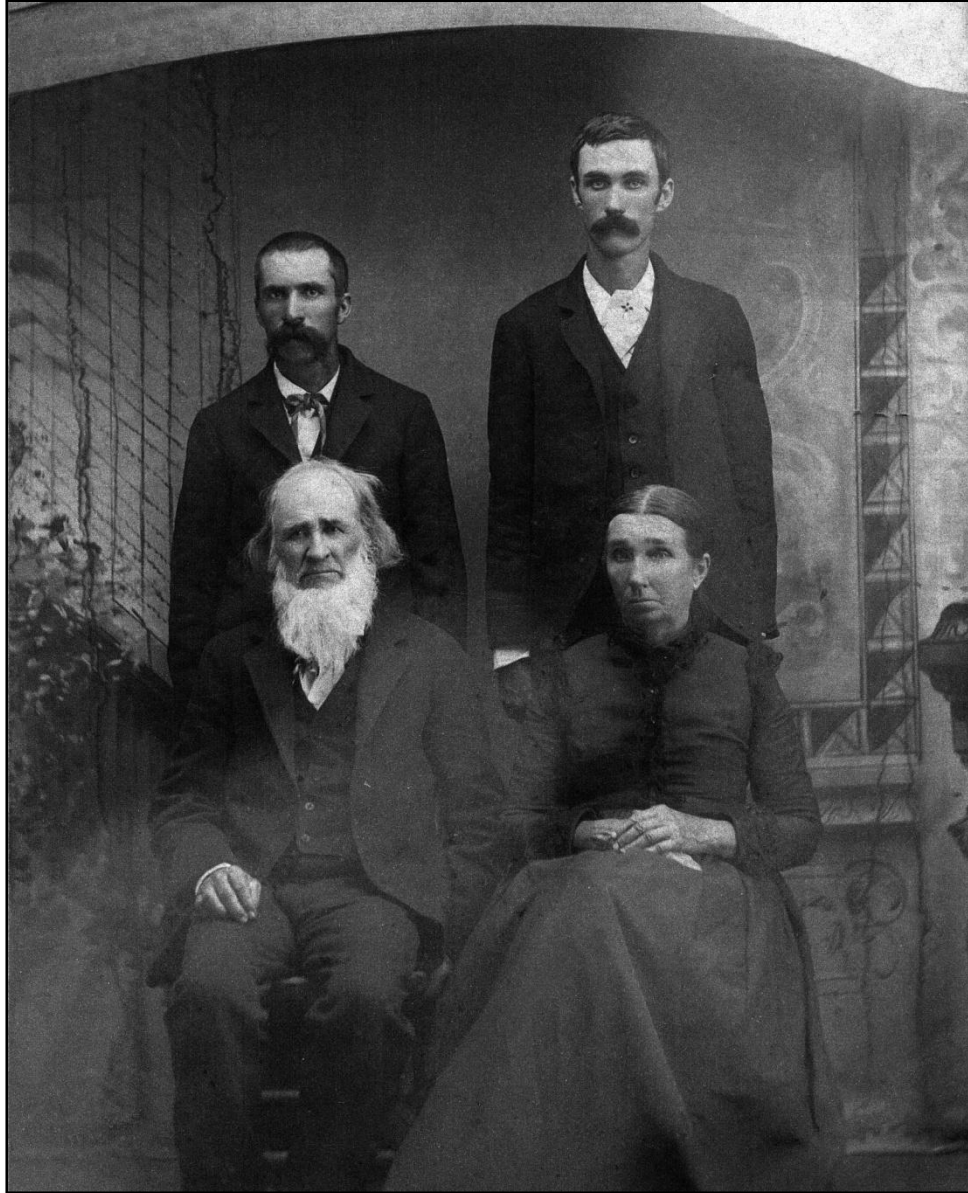

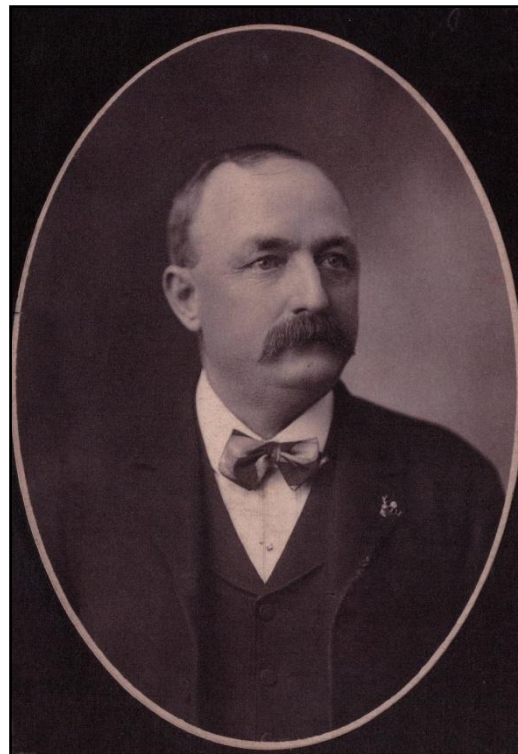
